- 3. While applying online, latest passport size photograph (not more than 50kb), signature of candidate (not more than 25kb) and a file in PDF (not more than 5mb) containing NOC, Experience Certificate(s) and Educational documents is required.



- 4. Candidates applying for the post must ensure that he/she fulfills all the eligibility conditions as on the last date of the application. If on verification or at any later stage, it is found that he/she does not fulfill any of the eligibility conditions or it is found that the information furnished is false or incorrect, his/her candidature/appointment will be cancelled.
