Major Features of the Guidelines adopted for engagement of Domain Experts (Health and AYUSH) in Shri Krishna AYUSH University Kurukshetra as well as other conditions are as under:-

**Allowances:** Domain Experts who are engaged form open market or retired government employees shall not be entitled to any allowance such as HRA, residential accommodation, CGHS, Medical reimbursement etc.

**TA/DA:** The level of entitlement for Travelling Allowance (TA) to the Domain Experts engaged from open market will be based on their monthly remuneration. The Domain Experts will be entitled to TA only when on official tour as per the 'Guidelines for engagement of Domain Experts (Health and Ayush) in Shri Krishna Ayush University Kurukshetra.

# **Retired Government Servants:**

i. The retired Govt. servant engaged as Domain Expert shall continue to draw pension and Dearness Relief on pension during the period of his/her engagement as Domain Expert.

ii. The engagement as Domain Expert shall not be considered as a case of re-employment.

#### Leave:

Paid leave of absence may be allowed at the rate of one day Casual Leave and one day Medical Leave for each completed months of service subject to maximum 10 Casual Leave and 10 Medical Leave during one calendar year i.e. as per Haryana Kaushal Rozgar Nigam Limited' Policy. Accumulation of leave beyond a calendar year will not be allowed.

### **Termination of Agreement:**

The University retains the right to terminate the contract at a time without giving any notice and also without assigning any reason. Some of the situations under which the University may terminate the contract are:

- i. The Domain Expert is unable to address the assigned work.
- ii. Quality of the assigned work is not up to the satisfaction of the Officer/Department.
- iii. The Domain Expert is found lacking in honesty and integrity.

#### **Police Verification:**

The Domain Expert form Open Market and the retired employees other than Central Govt. shall be engaged after verification of antecedent by the Police.

## **Vigilance Clearance-**

The retired Central Government Servant will be considered for post-retirement engagement only on receipt of vigilance/clearance subject to the condition laid out by the central vigilance commission's (CVC) Circular No. 07/05/21 Dated 03.06.2021.

#### Selection Criteria:-

The criteria for selection shall be interview based and the performance of the candidates shall be adjudged by the Selection Committee at the time of interview.

### General terms and conditions:

- 1. No person who is going to attain the age of 65 years will be considered for the engagement as Domain Expert.
- 2. The term of engagement shall ordinarily be for an initial period not exceeding six months which is extendable by another six months.
- 3. The engagement of Domain Experts will be purely on contract basis and will not confer any right for regular appointment in the University/organization. The fresh engagement of Domain Experts in the University would be at the initial rates only as mentioned in the table above and not at the rates at which any person was earlier engaged as a Domain Expert in Deptt. of Health and AYUSH/Ministry of AYUSH/any other govt. organization/open market.
- 4. The University has the right to cancel advertisement issued for engagement of Domain Experts and not to proceed in the matter of re-engagement of Domain Experts, at any stage to accept or reject any or all applications without giving any explanation, whatsoever.
