## **CORRIGENDUM - 01**

The clause 6 (vi) of the State Government of Haryana notification no. No.1/51/2023-1 HBII dated 26.09.2023 for admission to MD/MS (Ayurveda) courses in Participating College(s) for Academic Session 2023 – 2024 is hereby amended as:

"should have completed satisfactorily one-year compulsory Rotatory Internship from Institutions recognized by the NCISM/State Govt,/Ministry of AYUSH for this purpose by 31.10.2023, as per the AACCC instructions vide letter no. Ref. No. AA-12013/3/2023-EP-I dated 19.09.2023."

In view of the above amendment the candidates who had not completed their Twelve months Compulsory Rotatory Internship at the time of admission / reporting for Round -1 and 2 of Haryana State PG Counselling at the time of applying and reporting to the allotted institute are instructed to submit an Undertaking (Annexure - A) regarding completion of the Internship on or before 31.10.2023, counter signed by the Head of Institution. Further the candidates must submit their Original Compulsory Rotatory Internship Completion Certificate and Transfer Certificate / College Leaving Certificate on or before 06.11.2023, Permanent Registration certificate issued by the NCISM / State Board of Ayurveda on or before 01.12.2023 otherwise, his / her admission stands cancelled.
