- 1. The above post shall be filled-up on deputation basis.
- 2. The interested & eligible candidates/employees working on regular basis in any Haryana Govt. Department including State Universities; Govt. Medical Colleges/Institutes recognized by MCI or Govt. AYUSH Colleges/Institutes recognized by NCISM may apply through proper channel w.e.f. 22.04.2025. They shall also upload "No Objection Certificate" (as per Annexure-I) from their present employer or submit the same at the time of interview, failing which their candidature will not be considered.
- 3. While applying online, latest passport size photograph (not more than 50kb), signature of candidate (not more than 25kb) and a file in PDF (not more than 5mb) containing NOC, Experience Certificate(s) and educational documents are required.
- 4. Candidates applying for the said post must ensure that he/she fulfills all the eligibility conditions as on the last date of submission of application. If on verification or at any later stage, it is found that he/she does not fulfill any of the eligibility condition(s) or it is found that the information furnished is false or incorrect, his/her candidature/appointment will be cancelled.
