REVISED NOTIFICATION

In partial modification of vide notification no. 277 on dated 07.11.2023. It is hereby notified that the Hon'ble Vice Chancellor of the University, has approved the following amendment/alteration in the prevailing award of grace marks examinations rules for all Course/Diploma/Certificate of Shri Krishna AYUSH University Kurukshetra, under section 13(7) of University Act, to be implemented as under:-

- 1. Grace marks of 1% of the aggregate of Theory subject(s) of BAMS (New Syllabus) from academic session 2021-22, BHMS (New Syllabus) 2022-23 & all diploma/certificate 2023-24 will be implemented.
- 2. A candidate who fails in two subject(s) and in the aggregate may be given grace marks 1% of the theory aggregate marks of that professional/class. Total number of grace marks will be calculated on the basis of total aggregate marks of the theory subject(s) actually appeared in annual examination if by the addition of these marks he/she can anoitenim pass two subject(s) of the examination. Any unused residual grace marks calculated on the basis of total theory aggregates of fresh/annual examinations may be given in 136118. further supplementary /reappear examinations, but limited to two subjects in that professional/class only. No grace marks shall be given in Practical examination/internal assessment/viva-voca/clinical exam/seminar etc.
 - 3. Distribution of award of grace marks in the subjects shall be as under:
 - a) Preference shall be given to the subject in which minimum marks are required for passing.
 - b) In case of same/equal marks are required in different subject(s) grace marks shall be awarded according to serial number of subject(s) given in the scheme of the examination.
 - c) While awarding grace marks fraction working to (0.5) or more shall be rounded upto the whole number and fraction below (0.5) shall be ignored.
 - d) Subject passed with addition of grace marks will be shown with asterisk *
