Special re-evaluation of answer book rules (For mercy candidates only)

- 1(a). The interested mercy chance candidate will apply in prescribed form for special revaluation with a fee of Rs. 3000/- per paper within 20 days from the date of declaration of re- evaluation result of "No Change" by the Examination Branch. The committee consisting of Dean of concerned Faculty, HOD of concerned subject Teaching Department of the University/college and a subject expert will re-evaluate and analyse the answer book(s), as special revaluation, collectively. Any difference of grading /marking opinions among committee members shall be taken into account by calculating the average of marks awarded by each committee member. The result of such candidate (s) will be decided on the basis of the marks obtained by him/her in special re-evaluation and the marks obtained by the candidate (s) in earlier evaluation and re-evaluation will not be taken into consideration or carried forward in any case. Condition of increase /decrease of 20% marks shall not be applicable in special re-evaluation for mercy candidates.
- 1(b). A committee consisting of
 - (1) Dean of the concerned Faculty
 - (2) HOD of the Teaching Department of University/College.
 - (3) Controller of Examinations
 - (4) One subject expert

OR

Any other committee constituted by the Vice-Chancellor, If needed may consider and suggest some action against the evaluators /re-evaluators and or concerned officials of any serious breach of conduct and if any anomaly is brought to the notice of this committee by anyone who is involved in the special re-evaluation of mercy candidates.

2. For clarification(s) on any doubt or for interpretation of any provisions of these special re-evaluation of answer book(s) (for mercy candidate only) the decision of Vice-Chancellor will be final.
