TERMS & CONDITION FOR IIND FINAL STRAY VACANCY ROUND

- 1. If the seats still remain vacant even after the Final Stray Vacancy Round of counselling, then left over seats will be filled up via IInd Final Stray Vacancy Round.
- 2. The DCC takes no responsibility of any allotment made in the Final Stray Vacancy Round and shall not be held responsible for any wrong/incorrect allotment.
- All the registered candidates who were Not Allotted/Not Joined/Left after Joining, any seat in 1st/2nd/3rd or Mop-up Rounds/Stray Vacancy Rounds/ Final Stray Vacancy Round only are eligible for IInd Final Stray Vacancy Round.
- 4. There will be no online Fresh Registration of Candidates in IInd Final Stray Vacancy Round. Physical presence of Candidates along with original documents and complete tuition fee (accepted in both cash and in form of Demand Draft (DD) drawn in favour of Registrar, Shri Krishna AYUSH University, Kurukshetra payable at Kurukshetra) is must on the day of counselling.
- 5. Final Merit list of online registered candidates will be displayed at 01:00 PM in the SKAU, KKR campus on the day of IInd Final Stray Vacancy Round.
- 6. Candidate will be invited according to their merit and will be asked their preferred college/course and the seat will be allotted based on the availability.
- 7. All the documents of the Candidates must be physically verified by the College Authorities in consensus with Admission committee of SKAU, KKR.
- 8. Candidates must be physically present during the time of admission/verification of documents at the College. Any Authorized Person in absence of the Candidate will not be entertained.
- 9. A) If still the seats remain vacant then it will be filled by the candidates who will register themselves through offline mode in the registration form available in the campus on the day of stray vacancy round in between 09:00 am to 12:00 noon.
 - B) If needed, the merit list will be displayed at 01:00 pm on the same day.
 - C) All other formalities will be done after that.
- 10. All due precautions with regard to COVID-19 to be taken care of.
- 11. Non-NEET candidates shall be permitted to make admission for Homoeopathy Under Graduate course for the academic year 2021-22 which remained unfilled after all NEET qualified candidates have made their choices, subject to the final outcome of the Hon'ble Delhi High Court WP(C) 4626/2022.
