4. These Ayurvedic Medical Officers shall work as Technical Persons in the Pharmacy and they will also work as Ayurvedic Medical Officer in the University Hospital as & when required.

(MCQ based, mentioned in the **Annexure-A**). All the candidates on the basis of the information filled in the google form shall be allowed to appear in the Screening Test provisionally.

3. The result of the Screening Test shall be declared on the same day and the candidates as per the selection criteria shall be shortlisted for interview and they have to submit their application forms to the Document Verification Committee for checking their eligibility for the post. After verification of their eligibility, only the eligible candidates shall be allowed for interview. Therefore, all the candidates must bring copy of one set of their educational documents & experience along with original documents.
4. If during verification of document, it is found that any candidate who has been shortlisted for interview, but doesn't fulfil the requisite qualification, his/her candidature will be cancelled and he will not be allowed for interview.
