- **iii.** The candidates, who have already registered themselves and wish to participate in the next round, shall not be required to register again. However, they shall have to give their fresh choices of the College/course to participate in the second round of counseling.
- iv. The candidates who have joined the allotted seat in the 1st / 2nd round shall have a right to retain already occupied seat and this shall be changed only if he/she gets an updated and opted seat during 2nd / 3rd round as the case may be. However, the candidates who wish to participate in the 2nd / 3rd round of counseling will have to submit their choices/preferences of Colleges/ Institutes afresh again. Candidates who have been allotted seat (College) in previous round should give the fresh choices in order of preferences for the College/course in which they wish to upgrade themselves.
- v. The candidate who wishes to participate in the 2nd Round / onward of counseling and want to opt for State Quota Seats in Govt. Govt. Aided Colleges only shall be required to submit Rs. 5,000/-{Rs. 2500/- for SC/D-SC/BC/EWS/PWD/ESM/FF* of the State of Haryana (*if applicable)}, as SECURITY FEE at the time of fresh registration/choice filling for 2nd/ 3rd round of counseling through admission portal.
- vi. If the candidate wishes to opt for State Quota seats in Government as well as/or State Quota Seats/ Management Quota seats in Private BAMS/BHMS Institutes/Universities then he/she will have to deposit Rs. 50,000/-, as SECURITY FEE at the time of fresh registration/choice filling for 2nd / 3rd round of counseling through admission portal.
- vii. If a candidate does not deposit the requisite amount of Security Fee, then he/she shall not be eligible to participate in the second round of counseling.
 - a. **Security Fee** will be later **ADJUSTED** in the fee of first year course, if the candidate joins the allotted seat.
 - b. **Security Fee** will be **FORFEITED**, if a candidate who has been allotted a seat and does not join the respective institution or surrender the seat due to any unforeseen reason before and after joining.
 - c. **Security Fee** will be **FORFEITED**, if the admission gets cancelled due to any reason on the part of student. i.e in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within the stipulated time)
 - d. Security Fee will be **REFUNDED** (after completion of the admission process and following the process of refund) in case no seat is allotted.

c. Mop-Up Round of Counselling

If the seats still remain vacant even after the 3RD rounds of counseling, then left over seats will be filled up via Mop-Up Round as per direction of Ministry of Ayush, Government of India/NCISM/State Government and as per SKAU, Kurukshetra notified Schedule.

- i. The candidates who join the seat allotted to them during the 1st / 2nd / 3rd round of All India Counseling / State Counseling shall not be eligible to participate in the Mop-up Round.
- ii. No candidates would be allowed to participate in Mop up round counseling if he/she has already taken admission in any other institute under this University counseling/ All India Counseling. If such candidates want to participate in mop up round counseling, then he/she would have to get his/her admission cancelled (with documentary proof) before participating in mop up round counseling, their Security Fees submitted to the University shall stand forfeited. However, the candidates who wish to participate in the Mop-up round of counseling will have to submit their preferences afresh again.
- **iii.** Fresh registration shall be allowed for participating in the Mop-up round. Fresh candidates will have to register themselves on the University Admission Portal along with the necessary registration fee mentioned above. The candidates are advised to regularly visit the University Website and the University Admission Portal for updates.
- **iv.** The candidates, who have already registered themselves for previous rounds and are eligible to participate in Mop-up round as per the laid conditions and wish to participate in the Mop-up round, shall not be required to register again. However, they shall have to give their willingness/option to participate in the Mop-up round of counseling online, by filling up the choices/preferences again.
- v. The candidate who wishes to participate in the Mop-Up round of counseling and want to opt for State Quota Seats in Govt. Govt. Aided colleges only shall be required to submit Rs. 5,000/-{Rs. 2500/- for SC/D-SC/BC/EWS/PWD/ESM/FF* of the State of Haryana (*if applicable)}, as SECURITY FEE at the time of fresh registration/choice filling for 2nd/ 3rd round of counseling.
- vi. If the candidate wishes to opt for State Quota seats in Government as well as/or State Quota Seats/ Management Quota seats in Private BAMS/BHMS Institutes/Universities then he/she will have to deposit Rs. 50,000/-, as SECURITY FEE at the time of fresh registration/choice filling for Mop-Up round of counseling through admission portal.
- vii. If a candidate does not deposit the requisite amount of security fees, then he/she shall not be eligible to participate in the mop-up round of counseling through admission portal.
 - a. **Security Fee** will be later **ADJUSTED** in the fee of first year course, if the candidate joins the allotted seat.
 - b. **Security Fee** will be **FORFEITED**, if a candidate who has been allotted a seat and does not join the respective institution or surrender the seat due to any unforeseen reason before and after joining.

Subject: - Reservation for Economically Weaker Sections in Direct recruitment in Civil posts and services as well as in admissions in Government/Government Aided Educational Institutions in the State of Haryana.

I am directed to inform that government of India has notified "THE CONSTITUTION (ONE HUNDRED AND THIRD AMENDMENT) ACT, 2019" On 12th January, 2019 amending Article 15 & 16, which are now read as under: -

Amendment of article 15

In Article 15 of the Constitution, after clause (5), the following clause shall be inserted namely: -

(6) Nothing in this article or sub-clauses (g) of clause (1) of article 19 or clause (2) of article 29 shall prevent the State from making, -

- a). Any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5); and
- b). Any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5); in so far as such special provisions relate to their admission to educational institutions including private educational institutions, whether aided or unaided by the State, other than the minority educational institutions referred to in clause(1) of article 30, which in the case of reservation would be in addition to the existing reservations and subject to a maximum of ten per cent of the total seats in each category.

Explanation- For the purposes of this article and article 16, "economically weaker sections" shall be such as may be notified by the State from time to time on the basis of family income and other indicators of economic disadvantage."

Amendment of article 16

In Article 16 of the Constitution, after clause (5), the following clause shall be inserted, namely: -

"(6) Nothing in this article shall prevent the State from making any provision for the reservation of appointment or posts in favour of any economically weaker sections of citizens other than the classes mentioned in clause (4), in addition to the existing reservation and subject to a maximum of ten cent of the posts in each category".

In the wake of above enabling provisions, State Government has considered the matter and decided to provide benefits of reservation on a preferential basis in Civil Posts in all the Departments/Boards/Corporations/Local Bodies and in Admissions to Government/Government Aided Educational Institutions to those Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservation for the Scheduled Castes, Backward Classes (Block-A) and Backward Classes (Block-B).

2. QUANTUM OF RESERVATION:

The persons belong to EWSs who are not covered under the existing scheme of reservation for scheduled Castes, Backward Classes (Block – A) and Backward Classes (Block-B) shall get 10% reservation in direct recruitment to Group A, B, C and D posts in the Departments/Boards/Corporations/Local Bodies of Government of Haryana and also in admission to Government/Government Aided Educational Institutions in the State of Haryana.

3. **EFFECTING RESERVATION-ROSTER POINT:**

3.1 Direct recruitment in case of Group-A & B

Roster point No. 11-20-30-40-51-60-70-80-90 and 99

3.2 Direct recruitment in case of Group-C & D

Roster point No. 4-14-24-34-43-53-66-76-82 and 94

- 3.3 Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and will be filled from unreserved category.
- 3.4 Persons belonging to EWS selected against the quota for persons with benchmark disabilities/ex-servicemen shall be placed against the roster points earmarked for EWS.

4. CRITERIA OF INCOME & ASSETS:

- 4.1 Persons who are not covered under the exiting scheme of reservation for Scheduled Caste, Backward Classes (Block-A) and Backward Classes (Block-B) and whose family has gross annual income below Rs. 6.00 lakh (Rupees six lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e., salary, agriculture, business, profession etc. for the financial year prior to the year of application.
- 4.2 Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:
 - i. 5 acres of agricultural land and above;
 - ii. Residential flat of 1000 sq ft. and above;
 - iii. Residential plot of 100 sq. yards and above in notified municipalities;
 - iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
 - v. Total immovable assets owned are valued at Rs. One Crore or more.
- 4.3 The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- 4.4 The term "Family" for this purpose will include the person who applies for benefit of reservation, his/her parents, spouse as well as children and siblings below the age of 18 years.

5. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

- 5.1 The benefit of reservation under EWS can be availed upon production of an income and Asset Certificate issued by a competent Authority. The competent Authority for EWS Income and Asset Certificate shall be Tehsildar of the area where the applicant normally resides.
- 5.2 The prescribed format for EWS income and Asset Certificate shall be as provided at Annexure-I.
- 5.3 The Officer who issues the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the State.
- 5.4 The crucial date for submitting Income and Asset Certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise.

5.5 The appointing authorities should, in the offer of appointment to the candidates claiming to be belonging to EWS, include the following clause: -

"The appointment is provisional and is subject to the income and asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and provisions of the Indian Penal Code for production of fake/false certificate."

The appointing authority should verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority.

5.6 Instructions referred to above should be strictly followed so that it may not be possible for an unscrupulous person to secure employment on the basis of a false claim and if any person gets an appointment on the basis of such false claim, her/his services shall be terminated and penal action shall also be invoked.

6. ADJUSTMENT AGAINST UNRESERVED VACANCIES:

A person belonging to EWS cannot be denied the right to compete for appointment against an unreserved vacancy. Persons belonging to EWS who are selected on the basis of merit and not on account of reservation are not to be counted towards the quota meant for reservation.

7. The above scheme of reservation will be effective in respect of all direct recruitment vacancies to be notified on or after 01.02.2019.

No. Leg.15/2020.—The following Act of the Legislature of the State of Haryana received the assent of the Governor of Haryana on the 25th March, 2020 and is hereby published for general information:-

HARYANA ACT NO. 14 OF 2020

THE HARYANA SCHEDULED CASTES (RESERVATION IN ADMISSION IN GOVERNMENT EDUCATIONAL INSTITUTIONS) ACT, 2020

AN

ACT

to provide for reservation in admission in Government educational institutions to persons belonging to the Scheduled Castes in the State of Haryana with special measures for deprived Scheduled Castes and for matters connected therewith or incidental thereto.

Be it enacted by the Legislature of the State of Haryana in the Seventy-first Year of the Republic of India as follows:-

1. This Act may be called the Haryana Scheduled Castes (Reservation in Admission in Short title. Government Educational Institutions) Act, 2020.

2. In this Act, unless the context otherwise requires,-

Definitions.

- (a) "Annexure" means the Annexure appended to this Act;
- (b) "competent authority" means an officer appointed under section 5;
- (c) "deprived Scheduled Castes" means such Scheduled Castes as specified in Annexure;
- (d) "Government educational institution" means any higher education institution established and maintained by the Government or receiving aid out of the State funds, imparting education leading to the award of a degree including a post-graduate degree and shall include Government aided technical and professional institutions;
- (e) "Government" means the Government of the State of Haryana in the administrative department;
- (f) "prescribed" means prescribed by the rules;
- (g) "Scheduled Castes" means Scheduled Castes notified under article 341 of the Constitution of India.
- **3.** (1) Twenty per cent seats shall be reserved for the members of the Scheduled Castes Reservation. while making admission in Government educational institutions.
 - (2) Fifty per cent of the twenty per cent seats reserved for Scheduled Castes for admission in any Government educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as enumerated in the Annexure.

4. Where a seat set aside for candidate from deprived Scheduled Castes for admission in Government educational institutions is not filled up in any academic year due to non-availability of candidate of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes.

Copy of letter No.62/17/95-6 GSI Dated, Chandigarh, the 3rd October, 1996 received from the Chief Secretary to Government Haryana addressed to All Heads of Departments, Commissioners Ambala, Rohtak, Gurugram and Hisar Divisions, All Deputy Commissioners and all Sub Divisional Officers (Civil) in Haryana, The Registrar, Punjab and Haryana High Court and all District and Session Judges in Haryana.

Subject: "Bonafide residents of Haryana - Guidelines regarding".

I am directed to invite your attention to Haryana Govt. letters noted in the margin in the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical/medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile 'the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate: -

i) Candidates, who have passed the examination qualifying there for selection in an institution from a school/college in Haryana.

ii) Children / Wards (if parents are not living) / Dependents: -

(a) Of the regular employees of Haryana State posted in or outside Haryana State or working on deputation;(b) Of the regular employees of the statuary bodies/ corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana"

(c) Of the regular employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government;

iii) Children /wards (if parents are not living)/dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.

iv) Children/wards (if parents are not living)/dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a state other than Haryana or he has settled after retirement in or outside Haryana;

v) Children/Wards (if parents are not living)/dependents of persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana;

vi) The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage;

vii) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/ guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are:

a) Citizen of India;

b) Produce an affidavit to the effect that they or their children/wards (if parents are not living)/dependents have not obtained the benefit of Resident in any other State.

2. All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub-Divisional Officer (Civil) of the District/Sub-Divisions to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/Wards/Dependents of Haryana Govt, employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children /Wards/ Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/ Department of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/Wards / Dependents of the Statutory Bodies / Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by their respective heads of Departments.

3. Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana may not be required to produce Resident Certificate, if they have passed the examination from a school / college situated in Haryana. For this purpose, a certificate of the principal / Headmaster from concerned institution where the children/wards studied last school be considered sufficient. The Principal/ Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.

4. If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim was false, the student shall be removed from the institution, all fees and other dues paid up to the date of such removal shall be confiscated" The Principal/ Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case,

5. For the purpose of uniformity for issuing certificate of Residence in the case of various categories to be issued by the competent authorities, performas have been prescribed which are enclosed here with,


