**Terms & Conditions for Mop-up Round Counseling**

- Hon'ble Delhi High Court vide interim orders dated 24/02/2021 in the W.P. (C) 2334/2021, 2339/2021, 2342/2021, 2347/2021, 2343/2021 to participate in the ongoing counseling process subject to the outcome of W P. (C) filled by the concerned Institutions/Colleges. The names of colleges with seats are given as under:

Further in compliance of the direction of Hon'ble Delhi High Court it is required that all prospective candidates/ students have to submit an **undertaking/affidavit** in writing that their admission will be subject to the final outcome of writ petition filed by the respective Institution/College as mentioned above.

- Vacant Seats of colleges participated in previous rounds – will be notified in the tentative seat matrix for 2<sup>nd</sup> mop-up round.
- As per orders of Hon'ble Punjab & Haryana High Court in CWP No. 15731 of 2018, the reservation for admission under BC-A and BC-B Category will be provided to

candidates with GROSS ANNUAL INCOME up to 6 Lakhs with NO further classification i.e. up to 3 Lakhs and 3 to 6 Lakhs.

4. For PWD seat candidate has to produce relevant certificate issued by appropriate institution of Benchmark disability mentioned in point no. 2 of procedure for admission notification.
5. The candidates will have to deposit the remaining tuition fee in the form of DD at the college in favour of **Registrar, Shri Krishna AYUSH University, Kurukshetra** as mentioned at point no. 7 of the Tentative counseling Schedule, failing which his/her admission shall stand cancelled.
6. The personal appearance of the candidate at the time of document verification at concerned / relevant college is mandatory.
7. Any order of the Hon'ble Supreme Court / High Court / Amendments by the State Government / Government of India, Ministry of AYUSH /CCIM shall be applicable at any stage.
8. Admissions shall be made to only those institutes which are recognized and approved for admission from CCIM / Government of India and who have obtained consent of the affiliation from the concerned University. Those Institutes which are unable to get affiliation / approval from CCIM / State Govt. University shall not be considered for counseling.
9. Candidate should attain age of 17 years on or before 31.12.2020.
10. All documents must be produced in original along with two sets of self-attested photocopies and four Passport size Photographs. In case the students already deposited the original document in any other institute then, he / she have to produce the receipt of that institute regarding documents with an undertaking to submit the original document within a stipulated time as decided by the counseling Committee.
11. If any discrepancy/false statement in the documents of the candidates found therein subsequently at any stage, his / her admission shall stand cancelled. The fee will be forfeited and seat will remain vacant.
12. Any admissions made by any private BAMS/BHMS institutes including those under private university in the state at its own level shall not be valid and such admission shall be considered as null and void.
13. College concerned will constitute a document verification committee which will verify all the document of the student with their sole responsibility.
14. If any dispute / issue arise, in this regards the decision of Shri Krishna Ayush University shall be final.

The procedure of admission for 2<sup>nd</sup> Mop-up round will be followed as under:

University has received the orders from Hon'ble High Court Delhi about the vacant seats of above mentioned (point no. 1) colleges and as there are vacant seats remained after the 1<sup>st</sup> Mop-up round of the above mentioned (point no. 2) colleges, such seats will be filled up during the 2<sup>nd</sup> mop-up round of counselling.

- a.) Fresh registration shall be allowed for participating in the 2<sup>nd</sup> mop-up round. Fresh candidates will have to register themselves on the admission web portal along with the necessary registration fee mentioned in the notification of Govt. of Haryana. The candidates are advised to regularly visit the website of Shri Krishna AYUSH

University, Kurukshetra- [www.skau.ac.in](http://www.skau.ac.in), the admission web portal, registered email id and registered mobile no. for updates.

- b.) The candidates, who have already joined the allocated seats in any institute after first or second or 1<sup>st</sup> mop-up round can not participate in the 2<sup>nd</sup> mop-up round. If such candidates wish to participate in 2<sup>nd</sup> mop-up round then they have to vacate their joined seat first otherwise they will be declared ineligible.
- c.) The candidates, who have already registered themselves in first or second or 1<sup>st</sup> mop-up round of counselling, shall not be required to register again. However, they shall have to give their willingness/option to participate in the 2<sup>nd</sup> mop-up round of counselling online.

d.) The candidate (fresh or already registered) who wish to participate in the 2<sup>nd</sup> mop-up round of counselling and want to opt for State Quota Seats in Government/Government aided Ayurvedic/Homoeopathic Institutes **only** shall be required to submit the **Security Fee** (in addition to Registration Fee) Rs.15,000/- {Rs.7500/- for SC/BC/EWS/ESM/FF/PWD\* (\*if applicable)}, after submission of application form through **Demand Draft**.

e.) If the candidate wishes to opt for State Quota seats in **Government as well as State Quota Seats/ Management Quota seats** in Private BAMS/BHMS Institutes/Universities then he/she will have to deposit the **Security Fee** (in addition to Registration Fee) Rs.1,50,000/-, after submission of application form through **Demand Draft**.

**Demand Draft** – In favour of “Registrar, Shri Krishna AYUSH University, Kurukshetra”.

**(Should be submitted in the University latest by 05/03/2021 till 02:00 pm)**

**Important:**

**The candidates who have already deposited the security fee in 1<sup>st</sup> mop-up round and got approved from the University need not to deposit the security fee again. Although if a candidate opted only for Govt. seat and deposited 15,000/- or 7,500/- and now want to participate for pvt. College seats have to deposit full fee mentioned in point no. e.).**

**If the University will receive the above mentioned security fee in the form of DD in due time only then the candidate will be considered for the 2<sup>nd</sup> mop-up round.**

- f.) If a candidate does not deposit the requisite amount (Registration and Security Fee) then he/she shall not be eligible to participate in the 2<sup>nd</sup> mop-up round of counselling. This security amount shall be later adjusted in the fee of first year course if the candidate join the allocated seat.
- g.) The candidates who are allotted seats in the 2<sup>nd</sup> mop-up round of counselling but do not join or cancel the seat after joining; their security fee submitted shall stand forfeited.

- h.) The allotment of the course/institution shall be made strictly as per merit prepare/drawn on the basis of merit of NEET-UG-2020, and the choice/preference of the course/institute filled up by the candidate on the online portal shall be taken as final.

**Important Notes:**

1. No fresh registration to be done by already registered candidates and no fresh registration fee to pay.
2. Fresh candidates have to do registration and shall have to pay registration fee as per notification.

**Special Note:**

1. **EWS Candidate → Income & Assets Certificate → valid for 2020-21 of below 6 lakh.**
2. **BC-A & BC-B Candidate → Latest Income Certificate → upto 6 lakh.**
