SUBJECT: - PROCEDURE FOR ADMISSION TO UG (BAMS) & PG (MD AYURVEDA) COURSES COUNSELLING FOR ACADEMIC SESSION 2024 - 2025.

TERMS & CONDITION FOR STRAY VACANCY ROUND

1. The seats remain vacant in the participating colleges / institutes will be filled up via Stray Vacancy Round.
2. The DCC takes no responsibility of any allotment made in the Stray Vacancy Round and shall not be held responsible for any wrong/incorrect allotment.
3. All the registered candidates who were **Not Allotted/Not Joined/Left after Joining, any seat in 1st/2nd/3rd or Mop-up Rounds** only are eligible for stray vacancy round.
4. There will be **no online Fresh Registration** of Candidates in Stray Vacancy Round. All the candidates need to get themselves registered for the physical counselling by paying the Registration Fees (applicable for already online registered candidates also).
5. The seats of reserve category will be offered to the candidates of Respective category and in case of not available eligible candidates from the reserve category the seat will be offered to the candidate after conversion as per annexure of Notification.
6. **Physical presence** of Candidates along with original documents and complete tuition fee of the opted college (accepted in **cash at the Bank Counter or in shape of Demand Draft in favour of Registrar, Shri Krishna AYUSH University, Kurukshetra**) is must at the time of Admission.
7. Final Merit list of online registered candidates will be displayed at 01:00 PM in the SKAU, Kurukshetra campus on the day of stray vacancy round.
8. Candidate will be invited according to their merit and will be asked their preferred college/course and the seat will be allotted based on the availability.
9. All the documents of the Candidates must be physically verified by the College Authorities in consensus with Admission committee of SKAU, KKR.
10. Candidates must be physically present during the time of admission/verification of documents at the College. Any Authorized Person in absence of the Candidate will not be entertained.
11. A) If, still the seats remain vacant then it will be filled by the candidates who will register themselves through offline mode in the registration form available in the campus on the day of stray vacancy round in between 10:00 am to 12:00 noon.
B) If needed, the merit list will be displayed on the same day.
C) All other formalities will be done after that.
12. The Candidate who has been declared ineligible / blacklisted by the NCISM, joined in any AYUSH College in the state and Country is not eligible to participate in the present counselling.
