Terms & Conditions of Mop-up / 3rd round for MD/MS (Ayurveda) Course Counseling for Academic Session 2020-21

1. The candidate who wish to participate in the Mop-up/ 3rd round of PG counselling shall be required to submit Security Fee of Rs. 20,000/- {Rs. 10,000/- for SC/BC/EWS/ESM/FF/PwD* of Haryana State (*if applicable)}, at the time of form filling/ willingness or preference filling online. The fresh candidates will also have to submit registration fee as per Notification of P.G. Courses.

If a candidate does not deposit the requisite amount then he/she shall not be eligible to participate in the Mop-up/ 3rd round of counselling. This amount shall be later adjusted in the fee of first year course and refunded in case no

seat is allotted.

The candidates who are allotted seats in the Mop-up/ 3rd round of counselling but do not join or cancel the seat after joining, their Security Fee submitted shall stand forfeited.

The candidates who join the seat allotted to them during the first or second round of State counselling/ any round of All India Counselling or are in the ineligible list issued by the Central Govt. shall not be eligible to participate in the 3rd/Mop-up Round.

The candidates who have joined any seat but want to participate in Mop-up/3rd round, they have to surrender their joined seat first, then only they can apply for Mop-up/3rd round. In that case their security fee of Round-2 will be forfeited as per terms & conditions of Round-2.

If the seats remain vacant even after 3rd/Mop-up Round of counselling then left over seats will be filled up by clearing the waiting list, if the cut-off date will not be extended by Ministry of AYUSH/CCIM, New Delhi.

2. EWS Candidate → Income & Assets Certificate → valid for 2020-21 of below 6 lakh.

BC-A & BC-B Candidate → Latest Income Certificate → upto 6 lakh.

- The selected candidates will have to deposit the tuition fee in the shape of demand draft payable to Registrar, Shri Krishna AYUSH University, Kurukshetra at the time of joining, failing which his/her admission shall stand cancelled.
- 4. The personal appearance of the candidates at the time of joining and document verification at Shri Krishna Govt. Ayurvedic College, Kurukshetra is mandatory.

In case the students already deposited the original document in any other institute then, he/she have to produce the receipt of that institute regarding documents with an undertaking to submit the original document within a stipulated time as decided by the Concerned College.
- 7. For **PWD** seat candidate has to produce relevant certificate issued by appropriate institution of Benchmark disability.
- 8. For in-service candidate the NOC (No Objection Certificate) has to be produced within a stipulated time as decided by the Concerned College.
- 9. Candidate has to submit an undertaking in the form of affidavit that he/she is not pursuing M.D./M.S./PG Diploma (Ayurveda) in any Institute, anywhere in India.
- 10. If any discrepancy/false statement in the documents of the candidates found therein subsequently at any stage, his/her admission shall stand cancelled. The fee will be forfeited and seat will get vacant.
