**Terms & Conditions for MD/MS (Ayurveda) Course
Counseling for Academic Session 2020-21**

1. The candidates will have to deposit the fee in the shape of demand draft payable to Registrar, Shri Krishna AYUSH University, Kurukshetra at the time of joining, failing which his/her admission shall stand cancelled.
2. The personal appearance of the candidates at the time of joining and document verification at Shri Krishna Govt. Ayurvedic College, Kurukshetra is mandatory.
3. Any order of the Hon'ble Supreme Court/Punjab and Haryana High Court/Amendments by the State Government/Government of India, Ministry of AYUSH /CCIM shall be applicable at any stage.
4. All documents must be produced in original (like Matriculation, Senior Secondary (10+2), Mark sheet of B.A.M.S. I/II/III/Final year, Internship, B.A.M.S. Degree, Provisional/ Permanent B.A.M.S. Registration from State Ayurveda Council/ Central Council, Character Certificate issued by the last attended Institute, Haryana Resident/ Domicile, AIA-PGET 2020 Score Card, NOC, Benchmark Disability, Proof of Identification, Caste Certificate or any other relevant Certificate as per notification) along with two sets of self-attested photocopies and four Photographs. In case the students already deposited the original document in any other institute then, he/she have to produce the receipt of that institute regarding documents with an undertaking to submit the original document within a stipulated time as decided by the Concerned College.
5. For PWD seat candidate has to produce relevant certificate issued by appropriate institution of Benchmark disability mentioned in point no. 2 of notification
6. For in-service candidate the NOC (No Objection Certificate) has to be produced within a stipulated time as decided by the Concerned College.
7. Candidate has to submit an undertaking in the form of affidavit that he/she is not pursuing M.D./M.S./PG Diploma (Ayurveda) in any Institute, anywhere in India.
8. If any discrepancy/false statement in the documents of the candidates found therein subsequently at any stage, his/her admission shall stand cancelled.
9. If any dispute/issue arises, in this regards the decision of college admission committee shall be final.
10. Any kind of grievance will be entertained only on <https://skau.nopaperforms.com/pg-application-form>.
11. College concerned will constitute a document verification committee which will verify all the document of the student with their sole responsibility.
12. In future if any discrepancy or report of fake document is received in that case student and college will be responsible for cancellation of admission. The fee will be forfeited and seat will remain vacant.
