## Terms & Conditions for the 2<sup>nd</sup> round Counseling

- 1. As per orders of Hon'ble Punjab & Haryana High Court in CWP No. 15731 of 2018, the reservation for admission under BC-A and BC-B Category will be provided to candidates with GROSS ANNUAL INCOME up to 6 Lakhs with NO further classification i.e. up to 3 Lakhs and 3 to 6 Lakhs.
- 2. For PWD seat candidate has to produce relevant certificate issued by appropriate institution of Benchmark disability mentioned in point no. 2 of procedure for admission notification.
- 3. The candidates will have to deposit the tuition fee online through gateway as mentioned at point no. 8 of the Tentative counseling Schedule, failing which his/her admission shall stand cancelled.
- 4. The personal appearance of the candidate at the time of document verification at concerned / relevant college is mandatory.
- Any order of the Hon'ble Supreme Court / Punjab and Haryana High Court / Amendments by the State Government / Government of India, Ministry of AYUSH /CCIM shall be applicable at any stage.
- 6. Admissions shall be made to only those institutes which are recognized and approved for admission from CCIM / Government of India and who have

- obtained consent of the affiliation from the concerned University. Those Institutes which are unable to get affiliation / approval from CCIM / State Govt./ University shall not be considered for counseling.
- 7. Candidate should attain age of 17 years on or before 31.12.2020.
- 8. All documents must be produced in original along with two sets of self-attested photocopies and four Photographs. In case the students already deposited the original document in any other institute then, he / she have to produce the receipt of that institute regarding documents with an undertaking to submit the original document within a stipulated time as decided by the counseling Committee.
- 9. If any discrepancy/false statement in the documents of the candidates found therein subsequently at any stage, his / her admission shall stand cancelled. The fee will be forfeited and seat will get vacant.
- 10. Any admissions made by any private BAMS/BHMS institutes including those under private university in the state at its own level shall not be valid and such admission shall be considered as null and void.
- 11. College concerned will constitute a document verification committee which will verify all the document of the student with their sole responsibility.
- 12. If any dispute / issue arise, in this regards the decision of Shri Krishna Ayush University shall be final.

As per notification of Government of Haryana for procedure of admission for 2<sup>nd</sup> round will be followed as under:

In case there is vacancy after the first round of counselling due to any reason, such seats will be filled up during the second round of counselling.

- a.) Fresh registration shall be allowed for participating in the second round. Fresh candidates will have to register themselves on the admission web portal along with the necessary registration fee mentioned in the notification. The candidates are advised to regularly visit the website of Shri Krishna AYUSH University, Kurukshetra- www.skau.ac.in and the admission web portal for updates.
- b.) The candidates, who have already registered themselves for first round and wish to participate in the second round, shall not be required to register again. However, they shall have to give their willingness/option and fresh preferences to participate in the second round of counselling online.
- c.) The candidates who have joined the allotted seat in the first round shall have a right to retain already allotted seat and this shall be changed only if he/she gets an updated and opted seat during second round. However, the candidates who wish to participate in the 2<sup>nd</sup> round of counselling will have to submit their preferences afresh again. Candidates, who have been allotted, seat in first round should give the fresh choices in order of preferences for the Course/Institute in which they wish to upgrade themselves. The first preference

is mandatory and rest are on the choice of candidate where he/she wants to get admission. It is not necessary to fill all the preferences shown in the form. This counselling is for both courses B.A.M.S. & B.H.M.S., so while filling preferences one should ensure about the colleges offering these courses.

- d.) Candidates who are made ineligible or shifted to another category by any means are required to upload the relevant certificate in 2<sup>nd</sup> round of counselling to claim their eligibility of the applied category.
- e.) The candidate who wish to participate in the second round of counselling and want to opt for State Quota Seats in Government / Government aided Ayurvedic Institutes only shall be required to submit Rs. 5,000/- {Rs. 2500/- for SC/BC/EWS/PWD/ESM/FF\* (\*if applicable)}, at the time of filling up the form. If the candidate wishes to opt for State Quota seats in Government as well as State Quota Seats/ Management Quota seats in Private BAMS/BHMS Institutes/Universities then He/she will have to deposit Rs. 50,000/-, to be paid by both the candidates (already registered and freshly registered) at the time of form filling or updation (as willingness or preference filling) instead of at the time of document verification. The mode (online) & time of deposition of security fee has been changed due to Covid-19 pandemic.

If a candidate does not deposit the requisite amount then he/she shall not be eligible to participate in the second round of counselling.

This amount shall be later adjusted in the fee of first year course and refunded in case no seat is allotted.

- f.) The allotment of the course/institution shall be made strictly as per merit prepare/drawn on the basis of merit of NEET-UG-2020, and the choice/preference of the course/institute filled up by the candidate on the online portal shall be taken as final.
- g.) The candidates who are allotted seats in the 2<sup>nd</sup> round of counselling but do not join or cancel the seat after joining, their fee, mentioned in e.), submitted to the Admission Committee shall stand forfeited, however they will be eligible to participate in the mop-up round.

- 1. No fresh registration to be done by already registered candidates and no fresh registration fee to pay.
- 2. Fresh candidates have to do registration and shall have to pay registration fee as per notification.

### **Special Note:**

- a. Some colleges have not received permission from CCIM / Govt. of India, Ministry of AYUSH for admission in BAMS course for the session 2020-21. To avoid hardship to the applicants, preference for Colleges / Institutes (approved or non-approved) will be made, at the time of form filling or updation of preferences. At the time of allocation, only those Colleges / Institutes will be entertained who get approval till 04/02/2021 from CCIM / Govt. of India, Ministry of AYUSH. Till date the status of colleges/Institutes is given as under in the Table-A.
- b. EWS Candidates Income and Assests Certificate valid for 2020-21 of below 6 lakh.
- c. BC-A & BC-B Candidate Latest Income Certificate Upto 6 Lakh.
