## **Proposed Rule**

- 9 (a) student who has completed the prescribed course of instructions in a recognized college for first/second year examinations but does not appear in it or having appeared fails may be allowed, on the recommendation of the Principal of the college, to appear/reappear in the examination /paper(s) as the case may be as an ex-student without attending a fresh course of instructions in all available chances, within the period of four years of his/her admission to the course.
- (b) A Mercy chance/additional chance may be given by the Vice-Chancellor one time during the full course on medical illness Unavoidable or circumstances grounds.
