## **NOTIFICATION**

The Hon'ble Vice-Chancellor of the University has approved the following amendments by alteration/addition of all available chances, within the period of four years of his/her admission to the course / Diploma and one additional chance (mercy chance) in D.Pharmacy (Ayurveda) - 1<sup>st</sup> /2<sup>nd</sup> year and all two year diploma courses under section 13(7) of Shri Krishna AYUSH University Act to be implemented w.e.f the academic session 2018-2019 in larger interests of the students.

9. A student who has completed the prescribed course of instruction in a recognized college for first/second year examinations but does not appear in it or having appeared fails may be allowed, on the recommendation of the Principal of the college, to appear/re-appear in the examination /paper(s) as the case may be as an ex-student without attending a fresh course of instruction, only twice within the period of four years of his admission to the course.	9 (a) student who has completed the prescribed course of instructions in a recognized college for first/second year examinations but does not appear in it or having appeared fails may be allowed, on the recommendation of the Principal of the college, to appear/re-appear in the examination /paper(s) as the case may be as an ex-student without attending a fresh course of instructions in all available chances, within the period of four years of his/her admission to the course.  (b) A Mercy chance/additional chance may be given by the Vice-Chancellor one time during the full course on medical illness or Unavoidable circumstances grounds.
