1. The above post shall be filled-up on deputation basis.
2. The interested & eligible candidates/employees working on regular basis in any Haryana Govt. Department including State Universities; Govt. Medical Colleges/ Institutes recognized by MCI or Govt. AYUSH Colleges/Institutes recognized by NCISM may apply through proper channel w.e.f. **22.04.2025**. They shall also upload "No Objection Certificate" (as per **Annexure-I**) from their present employer or submit the same at the time of interview, failing which their candidature will not be considered.
3. While applying online, latest passport size photograph (not more than 50kb), signature of candidate (not more than 25kb) and a file in PDF (not more than 5mb) containing NOC, Experience Certificate(s) and educational documents are required.
4. Candidates applying for the said post must ensure that he/she fulfills all the eligibility conditions as on the last date of submission of application. If on verification or at any later stage, it is found that he/she does not fulfill any of the eligibility condition(s) or it is found that the information furnished is false or incorrect, his/her candidature/appointment will be cancelled.
5. No fee is required to be paid by the candidates for applying to the said post.
6. Submission of incomplete application may render the candidate ineligible.


