- Application duly completed in all respect are invited for the migration from another universities /institute/ colleges recognised by the NCISM, New Delhi to Institute for Ayurved Studies & Research, Faculty of Ayurved, Shri Krishna AYUSH University, Kurukshetra in 2<sup>nd</sup> professional of BAMS courses (Admission Batch 2022-23) after passing the 1<sup>st</sup> professional of BAMS courses from the Universities / Institutes / Govt. / private colleges duly recognized by the NCISM against the notified 14 vacant seats.
