Selection Criteria: The criteria for selection shall be interview based and the performance of the candidates shall be adjudged by the Selection Committee at the time of interview.

Duration: The persons would be engaged on daily wages (part-time basis @ 5½ hours per day) and initially the engagement will be made for **80 days** or till further orders, whichever is earlier.
