Allowances: Superannuated person of Non-Teaching Cadre shall not be entitled to any kind of allowance or accommodation facility e.g. Dearness Allowance, Transport facility, Residential Accommodation, Personal Staff and Medical Reimbursement etc.

TA/DA: No TA/DA shall be admissible for joining the assignment or on its completion. TA/DA as admissible as per rules will be paid to him/her after obtaining approval of competent authority if they are sent for official duty outside the University.

## Desirable experience and age limit of superannuated persons of Non-Teaching Cadre:

- The Superannuated person shall be appointed to the same post or one step lower post from which he was superannuated as per his/her suitability.
- No superannuated person shall be appointed to the higher post.
- The Superannuated persons shall be engaged against the vacant sanctioned post only.
- The maximum age for engagement of Superannuated person of Non-Teaching Cadre shall be 65 years and the age should not more than 63 years as on 03.12.2024 i.e. at the time of engagement.

#### Selection Criteria:-

The criteria for selection shall be interview based and the performance of the candidates shall be adjudged by the Selection Committee at the time of interview.

## General terms and conditions:

- 1. The initial engagement as Superannuated person(s) of Non-Teaching Cadre would be for a period of **six months** or for the period as desired by the University.
- 2. The review of the contract of the Superannuated person(s) of Non-Teaching Cadre will be done on tenure or annual basis whichever is less.
- 3. The appointment of Superannuated persons of Non-Teaching Cadre is of a temporary nature against the specific jobs. The Superannuated person of Non-Teaching Cadre will not be entitled for benefit/compensation/absorption/regularization any of service with the University.
- 4. The University may terminate a contract of Superannuated person of Non-Teaching Cadre, if the Superannuated person of Non-Teaching Cadre:
  - Unable to address the assigned work.
  - Refuses to follow directions/orders of the reporting/controlling officer or Competent Authority.
  - c. Quality of output on assigned works is not up to the satisfaction of the University.
  - d. Lack of honesty and integrity.

The University reserves the right to terminate the contract, by giving fifteen days' notice to the Superannuated person of Non-Teaching Cadre. Termination shall be effected by written notice served on the Superannuated person of Non-Teaching Cadre and shall take effect in 15 days of delivery of such notice. The termination will be without prejudice to either party's rights accrued before termination.

However, the University may immediately dispense with services of the Superannuated person of Non-Teaching Cadre without any notice period, if the conduct and activities of such Superannuated person of Non-Teaching Cadre are detrimental to the smooth functioning of the University.

- The engagement of will be purely on temporary/contractual basis initially for a period of **Six months** or for the period as desired by the University authority.
