The Price Bid under the second cover shall be opened only those bidders who qualified in (PQQ/Technical bid).

- The payment for Tender Document Fee and e-Service Fee shall be made online directly through Debit Cards & Internet Banking Accounts and the payment for EMD can be made online directly through RTGS/NEFT.
