
## General Terms & Conditions:-

1. The above posts are to be filled-up by deputation basis. The candidates can be considered on same post or higher post who have the work experience or fulfil the eligibility criteria of the post.
2. The interested & eligible candidates/employees working in the Government Departments/State Universities of Haryana/examining body conducting public examinations may apply through proper channel w.e.f. **11.07.2022** They shall also upload "No Objection Certificate" (as per **Annexure-I**) from their present employer or submit the same at the time of interview, failing which their candidature will be cancelled.
3. The qualifications and experience for above said post are appended herewith at **Annexure-II**.
4. While applying online, latest passport size photograph (not more than 50kb), signature of candidate (not more than 25kb) and a file in PDF (not more than 5mb) containing NOC, Experience Certificate(s) and Educational documents is required.
5. Candidates applying for a post must ensure that he/she fulfils all the eligibility conditions as on the last date of the application. If on verification or at any later stage, it is found that he/she does fulfill any of the eligibility conditions or it is found that the information furnished is false or incorrect, his/her candidature/appointment will be cancelled.
6. Candidates will have to apply for each post separately. No fee is required to be paid by the candidates for applying any post.
7. Submission of incomplete application may render the candidate ineligible.


