



Terms & conditions of the engagement:

1. These engagements are purely on part time (on hour basis) as stop gap arrangement which shall be initially for a period of 89 days.
2. The duty hours shall be as per the requirement, but not more than 5½ hours per day.
3. The payment of wages will be calculated by the concerned office on the basis of hours, the person actually performs his/her duties during every month.
4. Since the engagement is on part time (on hour basis), no kind of leave/holidays are admissible.
5. At the time of reporting for duty, the selected candidate must bring his/her police verification report from the concerned Police Post/Police Station in which area he/she resides. Further, he/she also must bring his/her character certificate issued by the Sarpanch/MC/any Gazetted Officer.
6. The University reserves the right to terminate the engagement without any notice period, if the services are no more required or work & conduct is not found satisfactory.
7. The selected candidate must also submit an Affidavit to the effect that this engagement is purely on part time (on hour basis) and he/she will not claim for continuation/regularization in lieu of this engagement at any stage.
