
A general public auction of the written off material i.e. Angle iron scrap and wooden scrap as per the attached list will be held on the venue and dates/timings mentioned has under.

Terms and Conditions/instructions for participation in bid

- (i) Those willing to take part in the bid will have to deposit security of Rs. 10,000/- before the start of the auction, which will be returned after the completion of the auction.
- (ii) The security money for the highest bidders will be adjusted in payment, in respect of others it will be returned immediately after the completion of bid.
- (iii) The highest bidder shall have to deposit the minimum amount of 25% of the Bid offered on the spot and balance payment will be deposited before taking delivery of the material, failing which amount already deposited shall be forfeited without any notice or reference.
- (iv) The Vice-Chancellor, Shri Krishna AYUSH University reserves the right to reject the highest bid even without assigning any reason.
- (v) Only the Scrap Dealers will be allowed to deposit the security who bring Photo Identity card/Driving License,/Aadhar Card/PAN Card etc. before the Auction.
