

The Search-cum-Selection Committee constituted by Hon'ble Governor of Goa and Chancellor of Goa University, to recommend suitable names for the post of Vice-Chancellor of Goa University, hereby invites applications from distinguished academicians fulfilling qualifications and experience prescribed for the post of Vice-Chancellor of Goa University as per Goa University Statute SA-6(1)(b)(i), reproduced below :-

“A person possessing the highest level of competence, integrity, morals and institutional commitment shall be appointed as Vice-Chancellor. The person to be appointed as a Vice-Chancellor should be a distinguished academician, with a minimum of ten years' of experience as Professor in a University or ten years' of experience in a reputed research and/or academic administrative organization **with proof of having demonstrated academic leadership.**”
