Terms & conditions of the engagement:

1. These engagements are purely on part time (on hourly basis) as stop gap arrangement initially for a period of 80 days.
2. The duty hours shall be as per the requirement, but not more than 5^½ hours per day in any case.
3. The payment of wages will be calculated by the concerned office on the basis of hours, the person actually performs his/her duties during every month.
4. Since the engagement is on part time (on hourly basis), therefore, any kind of leave/holidays are not admissible.
5. At the time of reporting for duty, the selected candidate must bring his/her police verification report from the concerned Police Post/Police Station in which area he/she resides. Further, he/she also must bring his/her character certificate issued by the Sarpanch/MC/any Gazetted Officer.
6. The University reserves the right to terminate the engagement without any notice, if the services are no more required or the work & conduct of the person is not found satisfactory.

7. The selected candidates must also submit an Affidavit (along with joining report) to the effect that this engagement is purely on part time (on hour basis @ 5½ hours per day) and will not claim for continuation/regularization in lieu of this engagement at any stage.

All the selected candidates are required to submit their joining report to the Registrar, Shri Krishna AYUSH University, Kurukshetra immediately but not later than 25.06.2026 for further deployment. No engagement letters shall be issued separately; however, the selected candidates shall be informed telephonically in this regard.
