## CORRIGENDUM-1

- A. Considering the requests of the candidates seeking clarification regarding applying to the post of Ayurvedic Pharmacist (advertised against Advt. No. NT-02/2026) with the higher qualification, it is hereby clarified that:

Candidates possessing B.Pharma (Ayurveda) may also apply for the post of Ayurvedic Pharmacist and their marks of academic achievements shall be calculated accordingly as per the selection criteria mentioned under Phase-2.

- B. Considering the requests of the PwBD-LD and PwBD-VH category candidates applied for the post of Clerk against advertisement No. NT-03/2026 seeking exemption from Computer Typing Test, it is hereby clarified that:

The eligible PwBD-VH and PwBD-LD candidates applied for the post of Clerk under advt. No. NT-03/2026, having a certified physical/functional limitation affecting their ability to undertake the Computer Typing Test may exercise an option for seeking exemption from the Computer Typing Test which shall be governed by the following criteria in place of the criteria shown under Phase-I of the main advertisement:

- a) He/she shall not be required to appear in the Typing Test;
- b) He/she shall be permitted to appear in the Phase-II Written Examination, subject to fulfilment of all other eligibility conditions; and
- c) He/she shall be awarded zero mark against the 15-marks of Typing Test component.

The willing candidates are required to submit their option in the prescribed format (attached below) only on the email id [recruitmentcell@skau.ac.in](mailto:recruitmentcell@skau.ac.in) upto **20.09.2026** along with copy of- (i) Filled application form without any document; (ii) PwBD-VH/LD category certificate; (iii) certificate from the competent Govt. medical authority regarding physical/functional limitation affecting computer typing. The option once exercised shall be final and binding for the recruitment process.

- C. In partial modification of the advertisement, under Point No. 8 '**AGE LIMIT**', sub-point (I), in the table under column '**No. of years for age relaxation**' against Serial Number (iii), the words '**Group A & B posts**' may be read as '**Group C posts**'.

All other terms & conditions of advertisement and Selection Criteria will remain unchanged.
